

Oregon Project Independence (OPI)

The goal of OPI is to prevent or delay nursing facility placements.

Limited in-home caregiving services. (Up to 20 hours per month)

OPI (Age 60+) <u>Currently has Waitlist</u> OPI Pilot (Ages 19-59) <u>Program Open</u>

Services may include housekeeping, personal care, lunch meal delivery, emergency response systems, medication management.





Oregon Cligibility

ONE Eligibility System

Provides choice and convenience in how people in Oregon apply for and manage their benefits.

Eligibility Specialists

Determine financial eligibility for programs through Aging & People with Disabilities (APD) and Self-Sufficiency programs (SSP).

Programs include but not limited to:

- ✓ Medicaid (Oregon Health Plan)
- ✓ Supplemental Nutrition Assistance Program (SNAP)
- ✓ Employment Related Day Care (ERDC),
- ✓ Temporary Assistance for Needy Families (TANF)

Apply <u>online</u>, <u>by phone</u> or <u>in-person</u> with <u>ONE application</u>.



SNAP is a federal nutrition program designed to <u>supplement</u> the food budgets of people with a low income.

Our office can assist <u>ALL</u> Oregonians with SNAP applications.



Oregon Health Plan (OHP) is Oregon's Medicaid program. There are several health care programs available for lowincome Oregonians of all ages.



Medicare Savings Programs

Helps pay Medicare costs (Part A and/or Part B). Qualification dependent on income. No asset limits.

Oregon Health Plan & Medicare

OHP can help pay for things like Medicare premiums, deductibles, coinsurance, rides to appointments and dental care.

Medicaid pays for <u>long-term care</u> when eligible. Services may include caregiving assistance for help with daily activities, health related tasks and more.

Medicaid Long-Term Care

In-Home Care

Caregiver assistance provided in your own home.

Assisted Living, Adult Foster Home, Residential/Memory Care, Nursing Facility

Specialized Care

Case Managers help you access the services and resources you are eligible for and need.

The Oregon Home Care Commission supports homecare workers, personal support workers by defining qualifications, providing a statewide registry.

Oregon Home Care Registry

- On-line service matches people with qualified homecare workers.
- Find workers who provide <u>routine</u>, <u>emergency</u>, and <u>respite care</u>.

Employer Resource Connection

- Free program for those approved through Medicaid or Oregon Project Independence.
- Consultants offer support to hire, train and retain home care workers.

Care providers who support older adults & people with disabilities in their own homes.



The Homecare Worker Team

- ✓ Assist homecare workers (HCW) from start to finish!
- ✓ Accept and process applications, background checks.
- ✓ Help with sign-up for online orientation & trainings.
- ✓ Assist (HCW) with Provider Time Capture System.
- ✓ Process payroll, answer pay related questions.

Adult Foster Home Local Licensing Authority



The goal of adult foster care is to provide necessary care for seniors and adults with physical disabilities while emphasizing the resident's independence.

Adult Foster Home (AFH)

- Family home with five (5) or less residents
- 65+ years of age or adult with a physical disability.
- <u>Included:</u> Meals, housekeeping, assistance with residents' activities of daily living.



Adult Foster Home Local Licensing Authority

Licensing & Monitoring

- APD adult care/foster homes in Lane County.
- Orientation and record keeping to educate those interested in being licensed.
- Investigating complaints for Adult Foster Homes in Lane County.



Adult Protective Services

Responds to allegations of abuse or neglect.

- Persons aged 65 years +.
- Person with physical disabilities aged 18+
- Residents of licensed care facilities.

- Physical Harm or Injury
- Failure to Provide Basic Care
- Abandonment by the Caregiver
- Verbal or Emotional Abuse
- Financial Exploitation
- Unwanted Sexual Con
- Wrongful Restraint
- Involuntary Seclusion
- Self-Neglect
