Thank You by Bill Johnson

On behalf of the GTV Property Committee, Management and the Greentrees Maintenance Department, I would like to thank the folks who reside on Skyline Drive. During the last three weeks of March, Greentrees replaced the water services that serve your homes. You have had to put up with the construction, noise, traffic and water service interruptions. By the time you read this, the work should be complete and you are now enjoying water delivery with greater volume and flow.

As most of you know, Greentrees plans to replace all the water services on property over the next ten years. Skyline Drive has been the beginning of that process. What we have learned there will make it easier on the rest of Greentrees residents. We all owe you a thanks for your cooperation.

G.E.R.T. Report: Greentrees Cannot Store Water and Food for Emergencies by Ken Stone

There are three or four very critical preparations you should make in order to have some degree of comfort and survivability during a disaster. These are a supply of drinkable water, heat if no electricity, food for several days, and a toilet.

We can cut the cost of buying the needed supplies of

bulk water storage tanks and emergency food supplies by making a bulk purchase through the office at Greentrees. How much we save will depend upon the number of people taking part. I am planning an order form with estimated prices that can be obtained from the office. The price will vary with the number of units ordered.

One good method of insuring adequate water is to fill a large drum of chlorinated water that can be stored for up to 5 years, before it needs replaced. I have a 55 gallon tank in my garage for this purpose. This tank is approved for storage of drinkable water and will not leach other chemicals into the water.

An emergency food supply is another problem. There are several possibilities for this. I recommend getting emergency food bars to put in your to-go bag and in your car. They are portable, good for 5 years under adverse conditions. These bars do not take up much space, do not induce thirst, and contain sufficient calories for 3 days each. They are generally healthy foods. An alternative is MREs (meals ready to eat). These generally require addition of water, but offer a variety in foods. They also need to be stored properly. Finally, one can stockpile store-bought foods for emergency use, but these must be rotated on a routine basis.

I will provide order sheets and product information at the Greentrees office by April 1, 2013.



As I mentioned in last month's column, your Board of Directors has been working on the Association's goals for this year. It appears the Board may ask owners to vote on a change to the CC&R's.

The Board met in a workshop on March 19th to discuss what many owners and board members feel is a priority: Tightening restrictions on

children living in Greentrees.

Our present CC&R's, which were approved by the ownership in 2004, allows underage residents to live in GTV for up to six months before the Association can take formal action to have them removed. Many believe this is too long for a fifty-five and older community. The Board discussed this at the March meeting, and feel that 90 days would be more appropriate. What do you think? Your district representatives would like to hear from you on this subject.

To tighten restrictions on children and other underage guests will require a vote of the owners. Seventy-five percent of all owners will have to vote in favor of any changes in order to amend our CC&R's, and that's never easy to get. So, before we make a large effort, we want to be reasonably certain that a large majority of owners would be in favor of such a change. Please let your district representative know.

We will be discussing this issue at the April board meeting. If you have strong feelings on under age restrictions, you may wish to attend and address the Board. It is also likely the Board will be going into Executive Session at the April meeting in order to consult with the Association's attorney on the subject. I encourage all interested residents to attend on April 9th at 1:00 PM.


Correction of March News Article

Board of Directors Meeting Minutes - March 12, 2013

<u>Call to order:</u> The meeting was called to order at 1:00 p.m. by President Fred Burns. All Board members were in attendance except E. Grenfell (dist. 2) and S. Muehlbauer-Lewis (dist. 8).

<u>Approval of Board Agenda</u>: **RB Taylor moved to approve the agenda as presented**. Voice vote approved Unanimously.

Approval of Prior Meeting Minutes: G. Lyddon moved to approve the minutes of February 12, 2013 and February 19,2013. A voice vote of the Board approved unanimously.

<u>President Burns Comments</u>: Mr. Burns presented a letter of resignation from Ron McCrary as chair of the Elections Committee. He thanked Mr. McCrary for his many years of service to Greentrees. We will be looking for a volunteer to chair the Elections Committee.

Residents' Forum: J. Fleming (#596) suggested that the Association get a plaque that has the names of past presidents and their terms on it, and place it in the Library. G. Romano (#168) announced that there will be a potluck sponsored by District 3 on March 22nd with line dancers and a raffle. All are invited. Rusty Mardock (#318) asked the Board for permission to have a gallery at her home to display her art work (President Burns asked her to come to the Board workshop on March 19th with more details).

<u>Treasurer's Report</u>: G. Lyddon presented Treasurer's Report. Balances are \$388,629 in Greentrees Operation accounts and \$331,552 in the Reserve accounts. The Association has spent \$47,429 of Reserve funds year-to-date. **Mr. Lyddon moved that the money market checking account that the Association holds at Oregon First Community Bank be closed and that the funds** (\$10,388) be rolled into the Oregon First Community reserve checking account. The Board approved unanimously (03-02-13).

General Manager's Report: The spa has finally been repaired by Emerald Pools. We haven't received a bill yet. We have replaced six water services on Skyline Drive (see pictures and replaced parts on table), and will complete three more this week. The 2012 Financial review will be completed on Friday and presented at the next B.O.D. meeting. Two liens were placed for delinquent assessments since the last Board meeting. The lot that the Association was foreclosing on has come current. There was a main water line break at the corner of South and 4th Street. It was repaired at a cost of \$3,000. The Greentrees website has been down. It is back up at a new address: greentreesvillage.org. The Directors and Officers insurance renewal had a large increase so we have put the policy out to bid.

Committee & Club Reports: (ACC) R.B. Taylor stated there was one permit issued in February to lot 672 for a storage building. (GERT) K Stone spoke on the need for individuals to have emergency food supplies and stored water. Mr. Stone suggested that a co-op of Greentrees residents could buy the supplies in bulk and save money. He will write an article for the GTV newsletter on the subject. (Property Committee) B. Johnson reported that the speed humps have been installed and will be painted when weather permits. The Property Committee is asking the Board to approve the purchase of electric eyes for the out-going property gates. The committee is discussing alternate ideas for marking lot numbers. Mr. Johnson reminded owners that if they wish to observe the water line work being done on property, they need to keep in mind safety issues. (Tuesday Club) No report. (Computer Club) No report.

<u>Unfinished Business</u>. (02-06-13) <u>City of Florence walking/bike path</u>: President Burns reported that he has spoken with the city after they received our letter of request. They offered to bring their consulting firm with them to our annual meeting in August to address the issue.

(02-07-13) Lot #94, Children: L. Dashofy read an e-mail from Mr. Schick (#94) which explained that the mother and three children had moved out of lot 94. Discussion followed. No action was taken.

(02-11-13) <u>Legal opinion regarding renters attending BOD meetings</u>: L. Dashofy read the Association's attorney's response to the Board's question as to renters being allowed to attend board meetings. The attorney advised that the Board was free to invite renters to attend. Discussion followed. **G. Romano moved that the attorney's response be made available to our owners.** Discussion followed. **Mr. Romano amended his motion to say that the attorney's letter be made available once owners' names were struck-out.** The Board approved unanimously.

(03-01-13) **B. Johnson moved that, for safety reasons, the Board accept the bid from Overhead Door of \$1543 to install electric eves on the exit gates at the Greentrees entrances.** The Board approved unanimously.

Announcements: There will be a board meeting (workshop), on March 19th at 1:00 PM to discuss changes to the CC&R's. Residents are welcome to attend. Thank you to the Tuesday Group for serving cake. Potluck, sponsored by District 3, on March 22^{nd} . Everyone is welcome.

G. Romano moved for adjournment at 2:03 PM. The motion was approved unanimously.
