Open Invitation to Greentrees Village Residents

Interested in better, more informative, entertaining radio? Noncommercial radio? Local radio you can help program or control?

West Lane Translator (WLT) a 53-year-old local non-profit, invites your participation to shape and support its new noncommercial community radio station effort, KXCR, 90.7 FM. WLT already provides free on-air television from four TV licenses and two broadcast towers south of Florence.

"Full-power KXCR expects to be on-air in 2013," says WLT Board member and Greentrees Village resident, Don Patton. "Commercially-independent stations offer important community benefits. Participation is wide open for local nonprofits, seniors, students, schools and folks with interest in sharing their passion for art, history, culture or civic affairs."

The FCC awarded WLT the noncommercial-educational permit following a 2007 decision to give away all remaining unused noncommercial FM spectrum in the US. Over 3500 applications crashed FCC websites in a fiveday "window." In October, 2010, WLT received the FCC award. Patton says, "Locally, WLT uniquely guaranteed local main studios with public participation in programming. All other applications were non-local. We wanted true community radio."

"To go on-air sooner, we need more volunteers and funding," says Don Landstrom, Mapleton-area resident. "We formed a nonprofit 501(c)(3), KXCR Community Radio Partners, to help obtain deductible funding. We

will be a volunteer-driven station with diverse programming and content that has integrity." Landstrom is President of KXCR CRP.

Greentrees Village Board Member Peg Patton, District 5, says "This is a great opportunity for GTV residents to participate in, and listen to, programs about senior needs and interests. There will be health, financial and governmental benefits topics as well as entertainment features focused towards seniors."

Planned KXCR facilities include their own leased building across from the library at the corner of Nopal and 9th street.

"We could use in-kind donations and hands-on support in rehabilitating this structure," says Bill Durst, officer with KXCR CRP. "We are reconfiguring the whole works, including kitchen and community spaces. Our goal includes buying this structure."

"For residents with ideas on programming or administration, now is the time to get involved." say Michael Titmus, programming co-chair. "We will be responsive to residents' interests. From Florence to Deadwood, join the effort and fun."

Programming will include national and regional perspectives. The London Guardian Newspaper has offered a unique content-access agreement.

"KXCR is dedicated to serving our entire community area, to the best of our abilities. We solicit your help in making this possible," says Geraldine McMahan, KXCR CRP board.

Board of Directors Meeting Minutes, December 11, 2012

President Fred Burns called the meeting to order at 1:00 P.M.

Roll Call of the Board of Directors: All Board members were present accept Jack Branson, District 9.

Approval of the Agenda: President Burns asked that the agenda be changed to allow guest speaker Rand Dawson to speak to the Board at the beginning of the meeting. **B. Prisbe-Sutton so moved. Motion approved unanimously.**

Approval of the minutes: **P. Patton offered a correction to the concert date in the November 12th minutes,** (to be Dec. 14th at 2:30 PM) and then moved that the minutes be approved as corrected. Motion approved unanimously.

<u>President's Comments:</u> Fred Burns thanked the Maintenance Department for the fine job they did in decorating the property for the holidays. He then introduced Rand Dawson.

(12-01-12) Community Radio: Mr. Dawson explained that he is an officer of the West Lane Translator Committee and as such, wished to discuss community radio with Greentrees Village. Mr. Dawson quickly outlined the history of establishing radio station KXCR (90.7 FM) and explained that the station must be on the air by October 2013 or they will lose the license which they fought so hard to obtain. Mr. Dawson discussed the benefits of community radio and asked the Board for Greentrees support. President Burns offered Mr. Dawson the opportunity to address the Greentrees Village residents by putting an article in the Association's newsletter.

Owner's Forum: Bill Johnson thanked the Board members for their efforts on behalf of Greentrees Village in 2012.

Correspondence: A letter was read from M. & M. Brown (lot 13) stating they were opposed to hiring an outside company to sweep the property's streets for economic reasons. B. Prisbe-Sutton read her letter of resignation to the Board (incorporated by reference). President Burns thanked Ms. Prisbe-Sutton for her service to Greentrees. Mr. Dashofy then read a letter of resignation from Director Jack Branson (also incorporated by reference).

<u>Finance Report</u>: D. Morgan reported that as of November 30, 2012 the Association had \$236,374 in the Greentrees Operation accounts and \$321,910 in the Reserve accounts. Year-to-date, the Association has spent \$101,564 in reserve funds. Ms. Morgan stated that at year-end, the Association was in good financial condition.

General Manager's Report: L. Dashofy reported that collection of assessments was improved by year's end. Two contractors are on property doing work. A retaining wall is being built on 5th Street, and ADA showers are being installed in the Family restrooms. The Association will soon begin work on phase three of the electrical line replacement. This will include 5th Street and part of 4th St. During the first quarter of 2013, twelve water lines will be replaced.

Committee and Club Report:

ACC: No report.

Bingo Committee: No report. Bingo resumes in January.

GERT/Security: No report.

Property Committee: B. Johnson reported that the Clubhouse ADA showers are nearly completed and that the retaining wall in front of lots 183-184 is being replaced.

Tuesday Club: Analee Tohill reported that Tuesday the 25th is the Christmas dinner. It will be free to residents, guests are \$5. 2013 Tuesday Club officers will be: President-Pam Spagna; Vice President-Sharman Stewart-Sutton; Secretary-Bette Turner; Treasurer-Joan Kerrebrock.

Computer Club: Pat Miller reported that the Computer Club officers for next year will be: President-Pat Miller; Vice President-Gene Fisher; Secretary-Parker Kendall; Treasurer-Connie Goddard; Advertising-Jack Branson.

Election Committee: L. Dashofy read the election results from the Election Committee. The newly elected Directors will be: District 2-Ella Grenfell, District 4- George Lyddon, District 6- Phillip Catalfamo and District 8- Sharon Muehlbauer-Lewis. Alternates will be Bill Johnson and RB Taylor.

Romano moved that the motion be postponed and brought to the 2013 Board. No second received. **The main motion was put to a vote: 4 yea (F. Burns, D. Morgan, D. Johnsen, B. Prisbe-Sutton), 4 nay.** Motion failed.
