July is here at last and we are all enjoying a beautiful Florence summer.

The Board is preparing for our annual meeting of owners and you will soon receive in the mail an invitation to attend the meeting on August 3rd.

Along with the invitation and agenda you will receive a copy

of the proposed 2014 budget. I'm happy to report that it appears there will be no increase in assessments next year. The City is increasing the rates for water, sewer and trash collection, but at this times it appears we will be able to absorb the increases without raising rates

You will also receive an owner survey in the mailing, and it is very important that you fill it out and return it to us. Here's why: One of the most common complaints that the Board receives concerns under-age people living in our fifty-five and older community. We don't have a lot of people here under fifty-five, but many believe that there should be even less - or none at all. However, our present CC&R's are not that strict.

Our CC&R's state that each lot must have **at least one person** fifty-five or older. That means that other members of the family can be younger than fifty-five. Our CC&R's also restrict children from living in Greentrees as a resident. However, they allow 'guests' to stay up to six months, and this could include children. Many owners feel that our rules are not strict enough and should be stiffened. The only way to do this is to change our CC&Rs.

To change the CC&R's requires a seventy-five percent approval of the owners. It's never easy to get that many people to agree on one thing. So before the Board proposes such a change to our documents, we want to be certain that the owners are sympathetic to the idea.

The survey you will receive asks if you are in favor of changing the requirements to be a resident in Greentrees, and also asks you specificly how you would prefer the new restrictions to read. The Board cannot act on your behalf if we don't know your feelings on the matter. So it is important that you return the survey to us in the stamped return envelope.

I appreciate you taking the time to let the Board know how you feel, and I hope to see you all at the Annual Meeting of Owners on August 3rd.

Sales on Property

At the Board of Directors meeting held on June 11th, the Board made changes to Item 10 of the Rules and Regulations concerning sales on property. The rule now reads as follows:

Because we are a gated community, garage sales are restricted in Greentrees Village. A garage sale, also known as a yard sale or rummage sale, is defined as an informal, irregularly scheduled event for the sale of <u>used goods</u> by a resident to the general public. The sales venue is a <u>garage</u>, <u>driveway</u>, <u>carport</u>, front <u>yard</u> or <u>porch</u>.

A few community sales are permitted each year in Greentrees. One is the Annual Flea Market sponsored by the Tuesday Club and normally held in July. The Flea Market is held in and around the Recreation Hall where residents may rent tables to display their wares. The Flea Market is open to the general public and residents are encouraged to participate. (Private garage sales or estate sales that take advantage of the gates being open for the Annual Flea Market are prohibited and subject to a fine of forty dollars (\$40) per occurrence).

A second is the Community Garage Sale sponsored by the Association and scheduled by the board of directors. This event is open to the general public and residents may display items for sale around their homes, on driveways, porches, decks, garages, etc.

For both events, the property gates shall be open and the public invited to attend. Temporary parking will be permitted. Aside from these community events, no other garage sales which are open to the general public are allowed.

Estate sales shall be allowed when there is a death of a lot resident. An Estate sale is defined as the sale of a deceased person's possessions or personal property. Estate sales conducted at the lot site shall require a permit issued by the Association office. Such sales shall require a parking monitor to insure that drive-ways remain open to ingress and egress, and that roads shall remain passable to traffic. Failure to do so shall incur a \$100 fine. For the purpose of an Estate Sale, the Board will permit the property gates to be open between the hours of 9:00 AM and 2:00 PM.

Emergency Information Sheets

After reading the *Message From the President* last month, many residents have been in to update their Emergency Information sheet kept on file in the office. If you haven't updated yours, please take a minute and stop into the office. Pick one up and fill it out. We'll keep it in your file in case of an emergency.

House Bill 2823

The Oregon House recently passed House Bill 2823, which would revise several portions of the Oregon Planned Community Act; the laws which govern homeowner associations in the state.

When the bill came before the Senate, several amendments were added to the bill that would be detrimental to Greentrees Village and other associations. These amendments deal with the very controversial issues of signage in HOAs and the question of what constitutes a "record" of an HOA.

The bill would essentially require HOAs to allow signs of any content be displayed, subject only to size and location. This would include signs that show pornography, racially inappropriate slurs, messages inciting violence and other such wording or images that would be a shock to the ideals that have been upheld by most HOAs.

The Community Association Institute, and other HOA organizations, urged homeowner associations to write their Representatives demanding that the law not be passed with these reckless amendments attached. Greentrees Management and Board members complied.

We are pleased to report that the bill did not pass with the amendments and that our own Representative, Caddy McKeown, voted against it, sending the bill back to committee.

We will keep you posted of any further developments.

Greentrees Village Inc. Board of Directors Meeting Minutes June 11, 2013

Call to order: the meeting was called to order at 1:00 p.m. by President Fred Burns. Eight Board members were in attendance. Guido Romano was absent.

Approval of Board Agenda: Peg Patton moved that the letter from President Burns to the city and the city's letter of response be moved to other business. Voice vote, 8 yes, approved unanimously. B. Johnson also moved that we move the discussion of the annual meeting to other business also. Voice vote, 8 yes, approved unanimously.

Approval of Prior Meeting Minutes: RB Taylor moved to approve the minutes of May 14, 2013, May 21, 2013 and June 4, 2013. Voice vote, 8 yes, approved unanimously.

<u>President Burns Comments</u>: We received a letter from our attorney regarding House Bill 28-23 of the State of Oregon which deals with two issues. One deals with signs in a homeowners association that states that people can display anything they want on a sign. The other portion of that bill is in regards to records. They can be used in a legalsuit. The attorney recommends that all residents should read this letter and respond to our State Representatives. You can get a copy of this letter in the Greentrees office.

Owners' Forum: M. Hill, Lot 603, lot occupancy on lot 562. A request was made by the board to put his comments in a letter and bring it to the Greentrees office.

Correspondence: A letter from Norma Parker, lot 64, regarding painting lot numbers at street edge and a thank you note from Gil and Sharon Zueger, lot 661.

<u>Treasurer's Report</u>: G. Lyddon presented Treasurer's Report. Cash on hand in our checking and savings account is \$370,293. The Reserve fund has \$320,644 for a balance of \$690,937. We are in very good shape on the profit and loss statement. Propane is \$15,327 below budget.

<u>General Manager's Report</u>: We are still seal-coating the designated streets. Hope to be done soon but that depends on the weather. If there is a delay due to weather we will keep the residents affected posted. The tennis court has the first coat and they are about to do the second coat. The tennis court will look like new when finished, but since last repair some of the cracks have expanded from 1/2" to $1 \frac{1}{2}$ ". We won't be able to do this kind of repair again. The Board needs to consider what to do with the tennis court in the long term. Starting next week we will be sending out letters to some lots regarding needed lawn maintenance. We placed one lien on a lot since the last board meeting. The annual meeting mailing will go out around July 5th and 6th. We will insert the resident survey at that time concerning the proposed changes to the CC&Rs. This Saturday there will be an open house on the East side. The gates will be open from 10 AM - 4 PM. There is a flyer that you can get at the Greentrees office entitled Statistical Review put out by the Foundation for Community Association Research for U.S. Homeowners Associations. It has lots of facts about Community Association Living. The family pool opens this Saturday the 15th. We have received the increase from the City of Florence. Trash pickup went up about \$5,000 a year. We are now paying \$9,268.00 a month.

<u>Committee & Club Reports:</u> (ACC) R.B. Taylor stated there was one permit issued to lot 271 for a carport. (GERT) K. Stone: He asked the audience how many from the West side had received a reverse call from 911. Many had not. They are supposed to call everyone in the yellow zone regarding a Tsunami warning. (Property Committee) B. Johnson reported that the Property Committee met last Tuesday and worked on the reserve budget and approved a tentative budget which was then given to the Finance Committee. They also discussed ongoing things like the retaining walls and the ADA restrooms. We might have to do the ADA bathrooms in a two year increment. The Property Committee meets on the first and third Tuesday every month at 10:00 AM and all homeowners are invited. (Tuesday Club) R. Smelley: There are still tables available for the flea market. The flea market will be held on July 27th from 8 AM - 2 PM. July 4th will be the annual hot dog feed. Foot long hot dogs, chips and drinks will be served to the residents free of charge. Guests cost is \$3.00. Lunch out will be at the Bridgewater on June 18th at 12:00 noon. (Computer Club) P. Miller: Starting in July we will be starting our summer schedule. They will be offering extra classes and workshops so look for the new schedule on the Club House bulletin board and in.

<u>Unfinished Business</u>. (02-05-13) Events notices posted at the Guard house. Discussion followed. A reader board was suggested. The Property Committee will discuss this issue and report back to the board. We will continue to post information until we hear back from the Property Committee. (05-06-13) Estate Sales: **F. Burns made a motion that Estate Sales shall be allowed at the death of a lot resident. Discussion followed. Roll call vote, 7 yes and 1 no, passed**. (05-07-13) HUD Survey: BOD to pick up surveys and lists of residents in the office. When board members go out to do the survey please remind the residents that they should update thier files with a house key and emergency names and numbers of next of kin. This information is kept in a locked file cabinet that only the office personnel have access to. This survey needs to be completed by the next board meeting.

<u>New Business</u>: (06-01-13) 2014 Budget: **RB Taylor moved to pass the 2014 budget. There will be no assessment increase. Roll call vote, passed unanimously.** (06-02-13) Owners Survey: **F. Burns made a motion to send out a stamped return envelope with the survey. Roll call vote, 8 yes, passed unanimously.** (06-03-13) Recording BOD minutes: **B. Johnson made a motion to not allow recording minutes except by the BOD. Discussion followed. Roll call vote, 8 yes, passed unanimously.** (06-03-13) Recording BOD minutes: **B. Johnson made a motion to not allow recording minutes except by the BOD. Discussion followed. Roll call vote, 8 yes, passed unanimously.** (06-03-13) Foreclosure: **G. Lyddon made a motion that the Association foreclose on Lot 9. Roll call vote, passed unanimously.** (06-05-13) Street Numbers: R. McCrary, Property committee did some research into having a youth group like Boys and Girls club paint the numbers on the street under supervision and then ask the resident if they would like to make a donation to thier group. **B. Johnson made a motion to have Ron McCrary work with the office on this project. Greentrees would provide the materials. Voice vote, 8 yes, passed unanimously.** (06-06-13) Webinar Electronic Seminar: An internet training seminar hooked up by telephone so you can communicate by voice. The big television can be utilized with one of the computers from the computer room. The cost is \$99.00 which would be paid by the association. A different subject is covered each month. This is open to anyone but the seating is limited. B. Johnson will get together with the computer club and also see what the classes are about. He will report back to the board.

Other Business: A letter was sent to the City of Florence to invite the consulting firm that is working on the bike/walking path on Rhododendron Drive along side Greentrees to attend our annual meeting. We received a response saying that they will not be attending our meeting because they have postponed the project for a year and a half. They have assured us that if anything comes up on the path they will contact us. A discussion followed. K. Stone is trying to have the West Lane Emergency Group commit to making a presentation at the annual meeting to discuss tsunami survival.

RB Taylor made a motion to give the General Manager and his staff recognition for a job well done. Voice vote, 8 yes, passed unanimously.

RB Taylor made a motion to adjourn the meeting. Voice vote, 8 yes, passed unanimously.
